1. **Call to Order:** Call to order at 4:31 PM by Chair Sadie Neuman.
2. **November Minutes:** Paul moved for approval, Sadie seconded. All in favor.
3. **Resident Concerns Update:** The CEQC discussed the Winona Post article about noise.
4. **Prairie Island Park Habitat Management Plan Update:** John shared that the contractor has exhausted the planning funds, and staff are determining the best way to proceed with finalizing the draft. City staff will need to do the outreach events, and likely would aim for early January after the holiday season.

CEQC members suggested having a couple breakout tables at the public input sessions for attendees to provide more specialized input. Maybe start with a presentation with some boards and then go to the in room breakouts for attendees. Maybe have Anne Conway of PI campground and Bird club present at stations.

Potential for WSU engagement. CEQC is glad to help.

5. **Winona County Hazard Mitigation Plan Update:**

Paul felt the references to plans are somewhat vague. Ideally more connection to how those influence responses.

Sadie was surprised that the plan is mostly natural hazard focused rather than all hazards. John said the City has all hazards team, which Sadie appreciates. Sadie would like to see more emphasis on personal preparedness.

Based on discussion, the CEQC suggested the following comments be forwarded to the plan coordinator:

- Suggest clarity on whether the plan is an all hazards mitigation plan or a natural hazards mitigation plan. The plan should be structured to maximize the ability to receive FEMA funding.
- The more ways the plan can be tied into existing plans, such as the City's comprehensive plan, the better.
- Support for personal preparedness and resilience education actions to help residents keep themselves safe.

6. **CEQC Priority Topics:**

Sadie shared about the prescribed fire council meeting occurring in about a month at WSU. Discounted rates for students.

Sadie discussed that data centers are a major topic, and there are steps communities can take to be able to be better prepared when proposals come in. RSDP is offering a training on data centers focused on SE MN.

Winona County has completed a draft of the County Wide hazard mitigation plan and is in the process of having participating entities approve the plan. The City of Winona had adoption on the Jan. 5th City Council agenda.

The CEQC discussion of the plan was passed on to the plan coordinator in early December. That correspondence is included for CEQC benefit below:

“Thank you for sharing the Citizens Environmental Quality Committee’s feedback it’s very helpful, and we appreciate their engagement with the Hazard Mitigation Plan. We shared it with the planning team.

Clarification on “All Hazards” vs. “Natural Hazards”

The Winona County HMP is a *natural* hazard mitigation plan, consistent with FEMA’s requirements under the Hazard Mitigation Assistance programs. While FEMA’s broader mission and some funding streams address “all hazards,” the HMP specifically focuses on natural hazards as defined by FEMA. We’ll clarify this more explicitly on the website and in future materials to avoid any confusion.

Alignment with Existing City Plans

We agree that integrating the HMP with the City’s Comprehensive Plan and other existing planning efforts strengthens both community resilience and plan implementation. We will look for opportunities to highlight those linkages more clearly, especially where mitigation actions directly support city goals around land use, infrastructure, and environmental stewardship.

Support for Personal Preparedness and Resilience Education

We appreciate the committee’s emphasis on resident preparedness. The HMP already includes several strategies related to outreach and education, and we will ensure these connections are clearly represented. We’re also happy to coordinate with the City on any ongoing or future efforts that promote personal preparedness and resilience for Winona residents.

Please let me know if the committee has any additional comments or if further clarification would be helpful. We value their input and look forward to continued collaboration.
