If approved, collections from the sales tax would replace property tax as the source for repayment of the \$28 million in bonds issued for the new jail, plus interest and bond issuance costs. The sales and use tax would be imposed for a period of not to exceed 25 years or until enough revenue has been raised to repay the bonds, whichever happens first.
